The Board will give till July 1, 2021 to hand in any paper work by a deadline of 3:30 pm and then he will be closing the Public Hearing. This way anything can be sent to the lawyer that night.

Gordon & Svenson LLP: Stated that the Zoning Board needs to take into consideration the Noise factor and the impact on the community and the traffic impact before making this discussion.
